#### **Product description**

Ultramid® C 216 V40 Black Z is a polyamide 6, reinforced with 40% of glass fibre, for injection moulding. This grade has good mechanical properties and offering an excellent combination between thermal and mechanical properties.

### **Injection Notes**

The material is supplied in airtight bags, ready for use. In case that the dried with a dehumidified air drying equipment, dew point mini -20°C. Recommended time 2-4h

- For reinforced polyamides, BASF SE recommends the use of steel with a high content of carbon, and purified for polishing, to avoid or limit the abrasion. For example: X38CrMoV5-1 (EN Norm) 1.2367 /1.2343 (DIN Norm) or X160CrMoV12 (EN Norm) 1.2601 /1.2379 (DIN Norm). In the case of high requirements on surface quality a mould temperature of up to 120°C can be considered.
- The processing parameters like processing temperatures are a recommendation and can be adjusted in function of injection machine size, part geometry / design.
